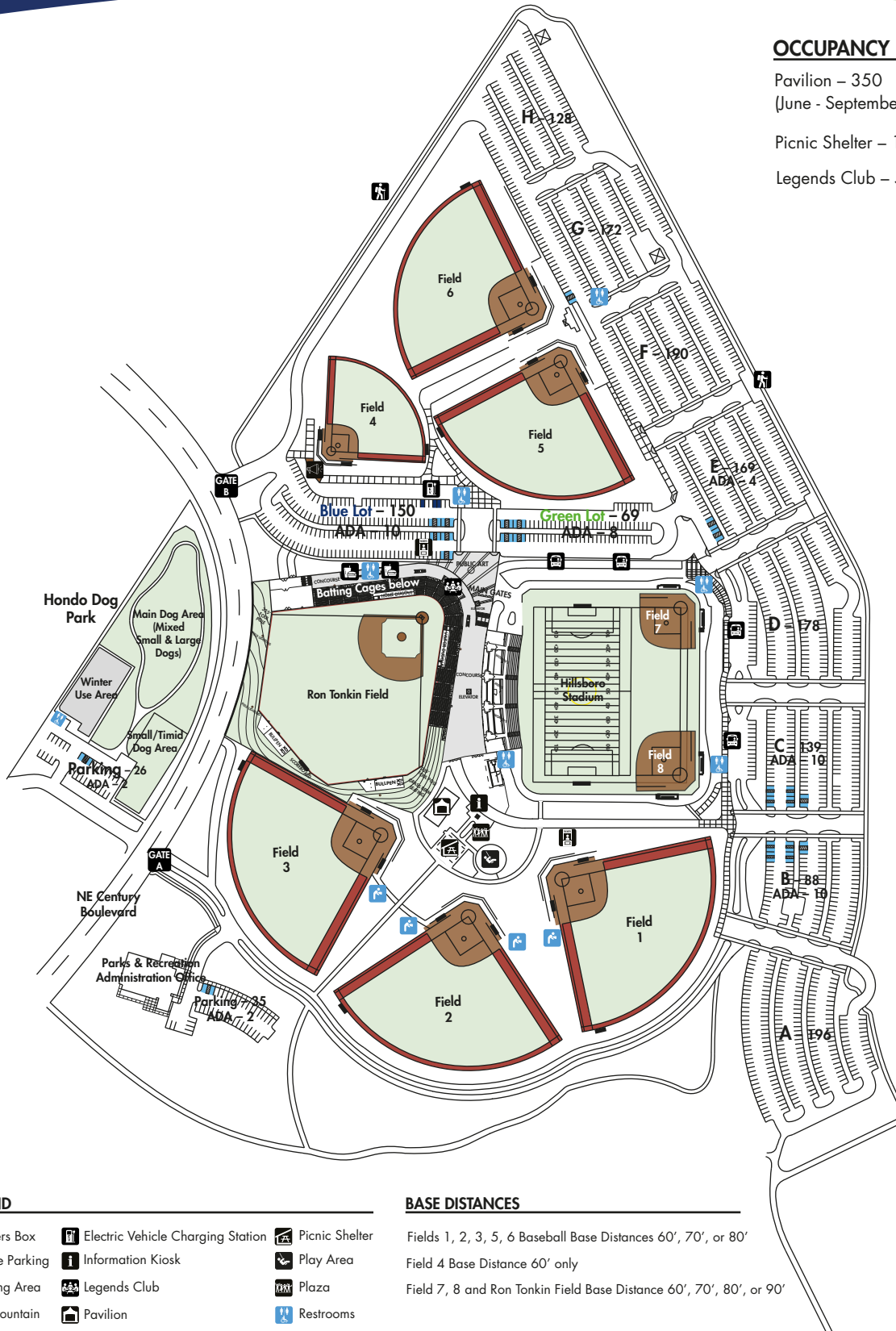
Facility Map
