SUMMARY:

This was the first meeting of the group. The first part of the meeting centered on welcoming and getting to know one another through a land acknowledgement, introductions, and an icebreaker. Then Ryan Stee and Jamie Stamberger gave presentations to explain the Parks System Planning process and equity focus to present the intended purpose and role of the CAC. Many CAC members were happy about the community and equity focus of the project and are happy to be involved in the CAC. The group agreed to a set of agreements about how to participate in the meetings that will be revisited at each meeting. Quite a few CAC members said this is their first time participating in a group like this. CAC members gave great feedback and ideas about how to best promote the community-wide survey, including methods and modes as well as locations for posting flyers with QR codes. Questions or comments about anything we've covered so far?

Many CAC members positively received the purpose and mission of the CAC and the Parks System Planning effort to engage in a transparent process and meaningfully include diverse communities in the planning effort unlike what the city has done before. Two specifically spoke about this:

Marco –really cool City of Hillsboro is actually considering the community's opinion. Feel honored and privileged to be able to share as part of the community, really cool angle to take. I want to say thank you for listening and giving us a chance as well and working together with all of us as a whole.

Diane – echo that this is a refreshing approach, Ryan said he's not used to doing things the normal dominant community way, I didn't realize that we would have a voice, so this is really nice, a voice heard by the people developing it, sometimes it feels empowering, and it is an honor, so thank you for taking that different approach and acknowledging how diverse our community is. It's awesome that we can all come together and work together and make a beautiful place for us and future generations to live.

Specific recommendations about parks:

One CAC member had a specific request for Hillsboro Parks:

Yasameen – I want to ask or have a complaint about recreation in Hillsboro: it's too crowded, is there a plan to create or divide new one? (for the pool specifically) we had to wait for families to leave so we could get in the pool. Hopefully in the plan you can make to add a new [aquatic center]. I tried to go to another one, but it's too expensive, Hillsboro is very nice, but it is too crowded, we can't swim, we can't move in the pool. The service is great the popcorn is great, the problem is too crowded, especially after 7, that's why we always go early morning and sometimes it's cold.
